From the conversations, we determined that some of the following needs to be reviewed: Tenant Representatives as members, change for dues increases to be voted on each November; what defines members in good standing; proxy elimination; draw directors from the membership and not from non members; delete reference to an Executive Committee; Officers only can be Directors; revamp the Purpose and fine tune it; change a quorum to be one third of the members; possibly establish non-voting members; add Electronic voting as an option with the actions taken to be included in the following months meeting minutes
