Brandon Easterling, Alliance Residential: Mr. Easterling spoke about his company's efforts to acquire the land and build an apartment complex on land in the Harper Park subdivision. Many neighbors attended from Oak Park and Oak Acres subdivisions which created a lively discussion. The rezoning is to be considered at the next meeting of the Oak Hill NPCT.

Brian Reis, Oak Hill Neighborhood Planning Contact Team (NPCT): Mr. Reis presented information on the functioning of the Oak Hill NPCT and the steps involved when a landowner wants to change the zoning on a property.

Ron Botts, Code Compliance, City of Austin: Mr. Botts described the functioning of the Code Compliance organization and how it was growing and expanding, and examples of different code enforcement issues that have been coming into play.
